## **Pennsylvania Superior Court Decides What Constitutes A “First Mortgage”**

01.22.2025 In a foreclosure action, what is a first mortgage? This is a question that does not seem too difficult to answer, but that is the question presented to the Pennsylvania Superior Court which, on December 31, 2024, reversed a trial court's decision clarifying that a first mortgage is the first mortgage lien of record at the time of a foreclosure action even if that mortgage was not the original mortgage lien having been recorded against the property. The issue was presented by Wilentz, Goldman & Spitzer, P.A. in the matter of Foxfield at Naaman's Creek Homeowner Association v. Eventoff; Appeal of Reverse Mortgage Funding, LLC, No. 1017 EDA 2024.
