Automobile and Truck Accident Claim Cases

- \$5.0 Million global recovery for two occupants of an automobile struck by a garbage truck
- \$4.1 Million settlement for young woman suffering from fractures of the ankle, wrist and leg as a result of a collision with a truck
- \$3.5 Million recovery for pedestrian struck by a bus who sustained brain trauma with resulting mild, short-term memory impairment
- \$1.4 Million recovery for 52 year-old woman who required a two-level spine fusion for herniated discs caused when her car was struck in the rear in automobile accident
- \$975,000 settlement for a woman who sustained two non-operated herniated discs to her cervical spine after her vehicle was struck by a military transport truck
- \$580,000 recovery for a woman struck in the rear by a motor vehicle who sustained a concussion
- \$485,000 settlement for woman who sustained knee injury requiring two surgeries from motor vehicle accident

Motorcycle Accident Claims

Federal Employee Liability Act (FELA) Railroad Claims

Product Liability Claims

- \$850,000 settlement for a woman injured when her hand became stuck in a nip point of an industrial machine
- \$500,000 recovery for a man who sustained mild neurological injuries when exposed to toxic fumes from a degreaser product

Fall Down Cases

- \$750,000 settlement for a man who sustained a lumbar disc herniation requiring surgery as a result of a slip and fall on ice on commercial property
- \$875,000 recovery for a man who tripped and fell on property causing aggravation of his preexisting thoracic herniated disc
- \$500,000 settlement for a woman who suffered a fractured ankle requiring open reduction surgery following a slip and fall on ice located on commercial property

Nursing Home Claims

Medical Malpractice Litigation
