Motor Vehicle Accident Claim Cases

- \$12.5 million global settlement for victims of a truck/school bus accident
- \$8.4 million verdict in a claim against a municipality for a passenger injured in an intersection accident attributable to a malfunctioning traffic light
- \$3.5 million recovery for bus driver involved in an intersection accident with an ambulance
- \$1.65 million recovery for child suffering a lumbar fracture in a school bus accident
