

Cannabis Law

Participation in the medical and adult-use marijuana markets raises important legal and regulatory questions and considerations. The 2021 adoption of personal cannabis Rules by the [New Jersey Cannabis Regulatory Commission](#) (CRC) has opened access to the New Jersey market for both existing and new market entrants. The CRC has begun the licensing process for several classes of business licenses in the state, including a newly created microbusiness license, which provides small business operators access to this new market. CRC Rules were developed to promote social equity, safety and provide access to the cannabis marketplace in New Jersey. These Rules also grant municipalities control over how they want cannabis businesses to operate within their jurisdiction.

Since the inception of New Jersey's medical marijuana program in 2010, members of our team have guided healthcare provider clients to navigate the state and federal regulatory framework. Health and Pharmacy Law
