

## BREAKING NEWS: Federal Courts Centralize All Cartiva Toe Implant Lawsuits into New MDL

February 5, 2026: In a significant victory for patients injured by defective toe implants, the United States Judicial Panel on Multidistrict Litigation (JPML) has officially ordered the consolidation of all federal Cartiva Synthetic Cartilage Implant (SCI) lawsuits.

By creating MDL No. 3172, the court has paved the way for a more efficient path to justice for individuals suffering from failed toe implants.

### **Why This Consolidation Matters for You**
