### **Motor Vehicle Accident Claims**

- Won a \$9.3 Million verdict for a 43-year old woman who suffered abdominal injuries and a fractured pelvis as a result of a head-on collision
- Recovered \$2.3 Million for a 32-year old machine operator who underwent cervical and lumbar surgery for injuries sustained when his van was struck by a garbage truck
- Secured a \$1.3 Million recovery for a 58-year old man who required a cervical fusion as a result of fracturing his neck when his car was struck in the rear by another car
- Recovered \$925,000 for a 55-year old man who underwent lumbar surgery and knee arthroscopic surgery after his car was struck at an intersection
