- Won an appeal in Superior Court of New Jersey Appellate Division, prevailing on behalf of an elderly Alzheimer's patient and her son in a case that clarified that the "caregiver exception" permits parents to transfer ownership of their homes, for less than fair market value and without fear of a Medicaid transfer penalty, to children who reside with them and provide care to them to the extent that the care delays the need for the parent to enter into a managed care facility or nursing home.
- Won an appeal in Superior Court of New Jersey Appellate Division, securing a civil reservation that protected his client from financial ruin, in the wake of a tragic case involving the death of an infant in the client's care.
- Won a significant arbitration award on behalf of a physician in a compensation dispute with his hospital employer.
- Won acquittal for truck-driver client who faced charges related to accidental death of pedestrian.
- Secured pre-trial dismissal of charges against public school teacher in alleged counterfeiting case.

- Negotiated numerous favorable pleas on behalf of clients facing serious criminal charges in state and federal court.
