He is also a founding member and the Chairman of Black Americans Lobbying for Leadership of Tomorrow, a political action committee created for the purpose of supporting elected officials and candidates whose policies and positions benefit, serve and empower people of African descent.

Mr. Johnson has served as a frequent speaker at the National Association of Bond Lawyers "Essentials" conference and at the New Jersey Institute for Continuing Legal Education.

Mr. Johnson was awarded Leadership Newark's Outstanding Corporate Partner Award, the Robert Lee Carter Legacy Award from the NJ State Conference of the NAACP, the ScoutReach "Good Scout" Award from the Northern New Jersey Council of the Boy Scouts of America, and recognized for his contributions to the economic development of the City of Newark by the Brick City Development Corporation.
